Record books and their associated indexes for the last five years have been scanned and attached to one index entry per scanned book. This allows for viewing of the records and indexes associated with those records one book at a time. Each book is scanned under the book number and Page 1. The book type (Index or Image) will be referenced in the name on the indexed record. For example, LAND RECORDS INDEX BOOK 111 would contain the name index for Book 111. LAND RECORDS IMAGES BOOK 111 would contain the documents in Book 111. Scrolling through the thumbnails of these scanned books will provide a similar experience as leafing through a physical book in the office.
